The board of Cessna Township Trustees opened in regular session on Monday, March 11th, 2024 at 7:00 P.M. at the township hall with the fiscal officer and all trustees present. The minutes from the previous meeting were read along with the presentation of the monthly financial reports. Mr. Vermillion moved to accept all reports as presented. Mr. Hull seconded the motion with all voting aye.

The board heard from the following guests: Michael Kassler and Kathy Kelley, Hardin County commissioner candidates.

Rich Williams, Hardin County Sheriff's Deputy asked the trustees for permission to place a mobile sheriff's office command center in the Cessna Township parking lot during the upcoming solar eclipse event. He asked that the township allow placement of the trailer from 4/6 through 4/9. He also asked for access to the restroom in the township hall. Mr. Eibling moved to approve the request with Mr. Vermillion seconding. All voted aye.

Mark Schwemer presented his monthly zoning update. He indicated that he was in the process of contacting the new owner of the triangle property to offer him the counties offer of razing the structure under the grant program. Mr. Schwemer also noted that he is preparing dates for the zoning board to meet about reviewing the townships zoning regulations.

Mr. Vermillion moved to donate \$75 to the Hardin County Fireworks display as done in previous years. Mr. Eibling seconded the motion with all voting yes.

The board received pricing on chip/seal on TR 90 from CR95 to CR135 and TR 105 from TR 90 to CR135 using #8 stone from the Hardin County Engineer's office. The estimate for TR 90 is \$63,463.41 and the TR 105 estimate is \$19,077.35. Mr. Eibling moved to proceed with the projects by way of force account with the Hardin County Engineer. Mr. Vermillion seconded with all voting aye.

It was noted that repairs have been made to the Freightliner truck that went out of service earlier this winter. The truck was towed to Stoops Express for repairs.

The John Deere tractor has also been serviced and is ready for the mowing season.

The annual township cleanup day scheduled for Saturday April 6th 2024 from 8:00 until noon is scheduled to coincide with a community open house for the new township building.
