The board of Cessna Township Trustees opened in regular session on Monday, February 12 at 7:00 P.M. at the township hall with the fiscal officer and all trustees present. The minutes from the previous meeting were read along with the presentation of the monthly financial reports. Mr. Vermillion moved to accept all reports as presented. Mr. Eibling seconded the motion with all voting aye.

The board offered the floor to Tim Stryker, candidate for Hardin County commissioner to speak. Mr. Stryker noted that he would be on the republican ballot in the primary election and gave the board a short presentation.

The trustees noted that the plow scraper blades on both trucks were worn and that they had been recently replaced by the trustees. No other issues were noted regarding snow removal to date.

Mark Schwemer was on hand to give his zoning report to the board. He updated the board on the current zoning issues in the township and was asked to stay on top of the properties on CR 90.

The board discussed the need for a tile in front of the John Point property on TR 100. After discussion was heard Mr. Long moved to approach Mr. Point with an offer to add an 18" tile to alleviate the water on the road and split the estimated \$3,100 total cost of the tile with Mr. Point paying \$1,600 of the expense. Mr. Eibling seconded the motion with all voting aye. Mr. Point was contacted by phone and the offer was presented. Mr. Point, who arrived at the meeting to discuss the issue in person, told the board he would consider their offer and get back to them. Both parties agreed that the tile installation would be beneficial to all.

The annual Cessna Township Spring cleanup was discussed. Mr. Vermillion moved to set the cleanup for Saturday, April 7<sup>th</sup> with Fall and Son providing the needed dumpsters. The motion also included the invitation to the Cessna Minuteman 4-H club to pickup roadside trash that same day in exchange for lunch and a donation of \$125 to the club. Mr. Eibling seconded with all voting aye.
